in consideration of the sum of One Thousand (\$1,000.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Allan R. Hawkins and his heirs and assigns forever:

All of that parcel or lot of land located in Oneal Township of Greenville County, South Carolina, situate about 2 1/2 miles northwest from the City of Greer and on the south side of a road which leads from State Highway No. 14 to the old Ansel School, sometimes known as the Holiday Road, being shown as Lot No. 3 on a plat of property made for Fred W. Garner by H.S. Brockman, Surveyor, dated August 30, 1956, and having the following courses and distances:

BEGINNING on an iron pin on the south side of said road and at intersection of said road and a street, and runs thence with the margin of said road, S. 89-30 W. 100 feet and S. 77-40 W. 103.5 feet to an iron pin; thence S. 2-40 W. 289 feet to an iron pin; thence S. 87-20 E. 200 feet to an iron pin on the west side of said street; thence along the margin thereon, N. 2-40 E. 321.3 feet to the beginning corner, containing 1.40 acres, more or less.

This is the same property conveyed to J.W. Pate and Christine B. Pate by deed of Fred W. Garner, dated September 1, 1956, to be recorded herewith.
