ALL THAT piece, parcel or lot of land situate, lying and being on the South-western side of Floyd Street in the County of Greenville, State of South Carolina being known and designated as Lot No. 92 as shown on a plat entitled "Monaghan Subdivision, Section Two" made by Piedmont Engineering Service, Greenville, S. C., May 1957, and recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 151, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Floyd Street at the joint front corner of Lots Nos. 91 and 92 and running thence with the line of Lot No. 91 S. 38-30 W. 160 feet to an iron pin; thence with the rear line of Lot No. 62 N. 51-30 W. 75 feet to an iron pin at the joint rear corner of Lots Nos. 92 and 93; thence with the line of Lot No. 93 N. 38-30 E. 160 feet to an iron pin on the Southwestern side of Floyd Street; thence with the Southwestern side of Floyd Street, S. 51-30 E. 75 feet to the point of beginning.

This conveyance is made subject to restrictive covenants applicable to Monaghan Subdivision, Section Two, recorded in the R. M. C. Office for Greenville County in Deed Book 581 at Page 309, and to an easement for the construction, maintenance and operation of a power distribution line given by J. P. Stevens & Co., Inc. to Duke Power Company, dated September 9, 1957, and recorded in the R. M. C. Office for Greenville County, South Carolina in Deed Book 584 at Page 137.



Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, successors, heirs and assigns forever.
