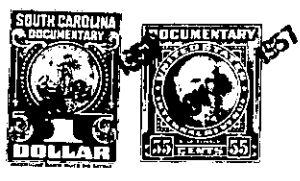

All that tract or parcel of land, lying, being and situated in the County and State afore-said, located on Miller road, near Mauldin, S. C. and being more fully described as follows:

Beginning at a nail and cap in the center of Miller road on line of the Grantor and running thence; S13W-580.2' to an I.P. on line of Corn Property; thence, S75E--145.1' to a nail and cap in Miller road; thence, with center of road N3-45W--116.8' to bend; thence, N3-10W--358.2' to bend; thence, N5-05E--129.8' to the beginning corner, and containing 0.83 acres, more or less.

This is part of the property conveyed to Grantor by deed from J. T. Bramlett and recorded in Book 234 at Page 294.
