All that piece, parcel and lot of land located in the City of Greenville, Greenville County, State of South Carolina, in the subdivision known as Sherwood Forest, being shown on plat of Sherwood Forest as Lot No. 78, made by Dalton & Neves, Engineers, August 1951, revised through June 1953, recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "GG", pages 70 and 71, and being more particularly described as follows:

BEGINNING at an iron pin on the east side of Don Drive, joint front corner of Lots 77 and 78 and running along the line of Lot 77 S. 32-19 E. 188.3 feet to an iron pin, joint rear corner of Lots 77 and 78; thence along the rear line of Lots 95 and 96 S. 60-01 W. 75.06 feet to an iron pin, joint rear corner of Lots 78 and 79; thence along the line of Lot No. 79 N. 32-19 W. 185.2 feet to an iron pin, joint front corner of Lots 78 and 79; thence along Don Drive N. 57-41 E. 75 feet to an iron pin, the beginning corner.
