TRACT I

All that piece, parcel or lot of land situate, lying and being in Chick Springs Township, State of South Carolina, County of Greenville, and having the following metes and bounds as shown by a plat of the Edwards Property recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book Q at page 13:

BEGINNING at an iron pin at the edge of the concrete pavement on the northwestern side of Warehouse Road and running thence N. 34-19 W. 172.7 feet to an iron pin on the eastern side of the right-of-way of the Southern Railway; thence with the eastern line of said right-of-way, S. 48-47 W. 221.0 feet to an iron pin on the eastern side of said right-of-way, which pin is also the northeast corner of a tract of land formerly belonging to the Estate of Vance Edwards, deceased; thence with the line of property formerly belonging to the Estate of Vance Edwards, deceased, S. 36-00 E. 146.5 feet to an iron pin on the northwestern side of Warehouse Road; thence with the northwestern side of Warehouse Road, N. 55-41 E. 215.3 feet to an iron pin, the beginning corner.

TRACT II

All that piece, parcel or lot of land situate, lying and being in Chick Springs Township, State of South Carolina, County of Greenville, on Warehouse Road, and having the following metes and bounds:
