That I, RUBY R. FERGERSON (same as RUBY R. FERGUSON), in the State aforesaid, in consideration of the sum of -----CORRECTION DEED-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Norma R. Duke:

ALL that piece, parcel, or lot of land located in the City and County of Greenville, South Carolina, known as the western portion of Lot Number 35, Section C, on a plat of Stone Land Company property, according to said plat of record in the R. M. C. Office for Greenville County, South Carolina in Plat Book A at Pages 333 and 345, and having the following metes and bounds, to-wit:

BEGINNING at a point on the southern side of Croft Street, which is 54 feet west of the northeast corner of Lot Number 35, and running thence N 83-13 W 54.9 feet to an iron pin at the corner of Lot Number 33; thence S 1-41 W 200 feet to an iron pin; thence S 83-13 E 54.9 feet to an iron pin; thence N 1-41 E 200 feet to the point of beginning.
