All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, being known and designated as Lot No. 4, as shown on a plat prepared by J. Mac. Richardson, dated February, 1958, entitled "Final Plat, Glendale Heights", recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book KK at page 143, and having according to said plat the following metes and bounds:

BEGINNING at a concrete monument at the intersection of Cross (Jacobs) Road and Glendale Street, and running thence with the Northern edge of Cross (Jacobs) Road N. 60-55 E. 64.5 feet to an iron pin at the joint front corner of Lots Nos. 4 and 5; thence with the line of Lot No. 5 N. 29-05 W. 140.5 feet to an iron pin in the line of Lot No. 7; thence with the line of Lot No. 7 S. 60-55 W. 64.5 feet to an iron pin on the Eastern edge of Glendale Street; thence with the Eastern edge of Glendale Street, the chord of which is S. 15-55 W. 35 feet to an iron pin; thence continuing with the Eastern edge of Glendale Street S. 29-05 E. 95.5 feet to an iron pin; thence with the curve of the intersection of Glendale Street and Cross (Jacobs) Road, a distance of 28.3 feet to the point of beginning.
