All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, State and County aforesaid, on the Southern side of West Parker Road, designated as Lot # 23, Block C of Hughes Heights Subdivision, as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book "GG" at pages 122-123, and having according thereto the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of West Parker Road at the joint front corner of Lots # 22 and 23; and running thence along the line of said lots S. 54-43 W. 160 feet to an iron pin; thence along the line of Lot # 24 N. 35-17 W. 80 feet to an iron pin on Nicholas Drive; thence along said drive N. 54-43 E. 136 feet to an iron pin; thence along the curve of Nicholas Drive at the intersection of West Parker Road S. 80-17 E. 35.3 feet to an iron pin; thence along West Parker Road S. 35-17 E. 55 feet to the point of beginning.
