

Konduros in consideration of the sum of Fifty (\$50.00) Dollars and the assumption of a first mortgage DOLKKARSK and the satisfaction of a second mortgage, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John L. Parker, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being at the westerly corner of the intersection of Glennwood Lane and Chesterfield Road, near the City of Greenville, S. C., being shown as Lot No. 16 on the plat of Woodfields, as recorded in the RMC Office for Greenville County, S. C. in Plat Book S, page 7, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Chesterfield Road, joint front corner of Lots 15 and 16, and running thence along the line of said lots N 38-23 W 123.5 feet to an iron pin in the line of lot 18; thence along the line of lot 18 N 43-11 E 132.9 feet to an iron pin on the southwesterly side of Glennwood Lane; thence along the southwesterly side of said Lane S 42-55 E 48 feet to an iron pin; thence continuing with the southwesterly side of said Lane S 38-23 E 68.8 feet to an iron pin at the intersection of said Lane with Chesterfield Road; thence around said intersection on a curve, the chord of which is S 6-37 W 35.3 feet to an iron pin on the northwesterly side of Chesterfield Road; thence along the northwesterly side of said Road S For deed into grantor see Deed Book 580, page 426. 51-37 W 110 feet to the point of beginning.

As part of the consideration the grantee assumes and agrees to pay the unpaid balance of \$5,530.33 due on that certain mortgage given by John L. Parker to The Peoples National Bank of Greenville, South Carolina, in the original amount of \$7,600.00, dated August 6, 1948 and recorded in Mortgage Book 396, page 479, said mortgage having now been assigned to The Teachers Insurance & Annuity Association of America.
