(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ottis R. Causey, his heirs and assigns, forever

All of my undivided one-third (1/3) right, title and interest in and to

all that piece, parcel or lot of land in Chick Springs Township, Greenville

County, State of South Carolina, containing 16.7 acres, lying on both sides of a County Road and having, according to a plat made by C. C. Jones, dated September 30, 1954, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of a County Road and in the line of other property now or formerly owned by T. W. Fleming, and running thence with the line of said property, S. 8-30 W. 395 feet to an iron pin; thence N. 77-30 W. 761 feet to a stone; thence N. 2-00 E. 441.6 feet to an iron pin in the center of the County Road; thence with said Road, N. 86-43 E. 66 feet to an iron pin at a bend; thence continuing N. 80-00 E. 142.9 feet to an iron pin; thence N. 3-49 E. 208 feet to an iron pin; thence S. 80-09 W. 145.6 feet to an iron pin; thence N. 86-42 W. 66 feet to an iron pin; thence N. 2-56 E. 529 feet to an iron pin; thence S. 63-00 E. 805 feet to an iron pin at corner of other property now or formerly owned by T. W. Fleming; thence with the line of said property S. 16-06 W. 523.5 feet to an iron pin in the center of a County Road above mentioned; thence with the center of said Road, S. 66 E. 191.6 feet to an iron pin, the beginning corner.
