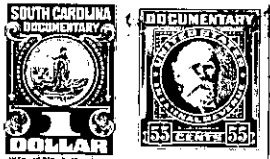
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) George T. Dill, Grantee, and his heirs and assigns forever, All of that certain piece, parcel or lot of land in O'Neal Township, County of Greenville, State of South Carolina, located one mile northwest from Greer, S.C. on the side of a hard surface road that leads from Highway No. 14 to Memorial Drive Extension, and being shown as tract number FIVE (5) on a plat of property made for Emery T. Dill by H.S. Brockman Surveyor, dated March 7th., 1958, and having the following metes and bounds, according to said plat, to-wit:

BEGINNING at a point in the center of said road (stake set off on North bank) at the corner of the George T. Dill property and running thence N. 2-20 E. 511 feet along the said George T. Dill property line to a point on the line of the Fred Clark property; thence S. 80-15 E. 114.7 feet along the Clark property line to the rear corner of lot No. 4; thence S. 5-36 E. 146.3 feet as the common line of lots 4 and 5 to a point in the center of said road (stake set off on north bank); thence S. 71-10 W. 93.6 feet along the center of said road to the beginning corner and containing one acre, more or less, and being all of the same lot of land ~~conveyed~~ conveyed to me by Emery T. Dill by deed dated the 20th., day of March 1958.
