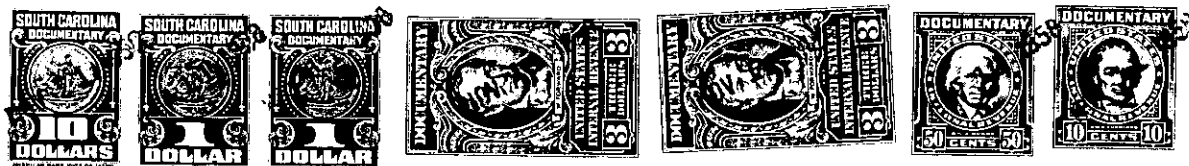

J. Austin Gault and Vada P. Gault, their Heirs and Assigns forever;

All that certain piece, parcel or lot of land, with the improvements thereon, lying, being and situate in the County of Greenville, Town of Fountain Inn, State of South Carolina, on Georgia Road, as will more fully appear according to plat made by E. E. Gary, Surveyor, dated March 31, 1948 and being more particularly described according to said plat, to-wit:

BEGINNING at an iron pin in the southern edge of the Unity Road, also known as Givens Farm Road, joint front corner with lot now or formerly belonging to Paul Martin Cox, running thence with the southern edge of said road S. 57-3/4 W. 80 feet to an iron pin, northeast corner of a corner of a fifteen (15) foot alley; thence with the eastern edge of said alley S. 32-1/4 E. 150 feet to an iron pin; thence N. 57-3/4 E. 80 feet to an iron pin joint back corner with lot now or formerly of Paul Martin Cox; thence with said Cox line N. 32-1/4 W. 150 feet to an iron pin, the point of beginning, and bounded by Unity or Givens Farm Road, a fifteen (15) foot alley, other lands formerly belonging to B. P. Garrett and lot now or formerly belonging to Paul Martin Cox.
