Know All Men by These Presents

That I, William L. Costner, in consideration of the sum of Six Thousand Six Hundred Twenty Eight and No/100 (\$6,628.00) --DOLLARS, and assumption of mortgage to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Bernard P. Wirl and Regina O. Wirl, their Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, on the southeastern side of Chesterfield Road and being known and designated as Lot No. 296 of Belle Meade, Section 3; as shown on Plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "GG"; at Page 187 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Chesterfield Road at the joint front corner of Lots Nos. 296 and 297 and running thence along the joint line of said Lots S. 57-52 E. 178.2 feet to an iron pin; thence S. 8-53 E. 30 feet to an iron pin; thence S. 66-0 W. 79.1 feet to an iron pin; thence N. 57-52 W. 153.7 feet to an iron pin; thence along the southeastern side of Chesterfield Road N. 32-08 E. 90 feet to the point of beginning.

The above is the same property conveyed to the grantor by Derby Heights, Inc. by its deed dated August 19, 1958 and recorded in Deed Book 605, at Page 123.

As part of the consideration of this conveyance the grantees assume and agree to pay the balance due on note and mortgage given by the grantor to Fidelity Federal Savings and Loan Association, which mortgage is recorded in the R. M. C. Office for Greenville County in Mortgage Book 757, at Page 131, the balance now due and owing being \$12,072.00.

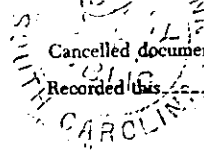
RENUNCIATION OF DOWER
