to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ethel S. Willis, her heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in Bates Township, Greenville County, South Carolina, being designated as Lot No. 3 according to plat made by J. C. Hill, L. S., December 6, 1958, recorded in Plat Book S.S. at Page 57, and having the following metes and bounds, to-wit:

BEGINNING at a nail and cap in the center of Shelton Road, the joint corner of Lots Nos. 2 and 3, and running thence with the line of said lots due west, 190.7 feet to iron pin on Merrell line; thence with Merrell line, due north 150 feet to iron pin; thence with line of Lot No. 4 due east, 189.7 feet to nail and cap in center of Shelton Road; thence with the center of Shelton Road as the line, S. 0-50 E., 125.3 feet to bend; thence S. 2 W., 25.1 feet to nail and cap in center of Shelton Road, the point of beginning.
