to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, L. M. Brown, his heirs and assigns forever:

All that certain piece, parcel of lot of land on Creek Shore Drive near the City of Greenville, in Greenville County, South Carolina, being known and designated as a portion of Lot No. 69 of Fresh Meadow Farms, Section I, as shown on plat thereof made by M. H. Woodward, May 21, 1945, and recorded in the R. M. C. Office for Greenville County in Plat Book M, at page 127, and being more fully described as follows:

BEGINNING at an iron pin on Creek Shore Drive at the joint corner of Lots Nos. 68 and 69 and running thence S. 81-10 W. 95.9 feet to an iron pin on Creek Shore Drive, joint corner of Lots Nos. 69 and 70; thence along the joint line of said Lots N. 8-37 E. 157.2 feet to corner of property of Land; thence along the line of property of Land S. 81-23 E. 87 feet, more or less, to a point in line of Lots Nos. 68 and 69; thence along the joint line of said lots, S. 8-37 W. 129.5 feet to the beginning corner, together with all rights and powers granted to Louie E. Smith by L. A. Moseley by deed recorded in the R. M. C. Office for Greenville County in Deed Book 560 at page 423; which rights, powers and authority were granted under power reserved to L. A. Moseley in restrictions recorded in said R. M. C. Office for Greenville County in Deed Book 289 at page 8: which said rights and powers were conveyed or granted to me by deed of Louie E. Smith by deed recorded in said R. M. C. Office in Deed Book 570 at page 183.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
