Know All Men by These Presents:

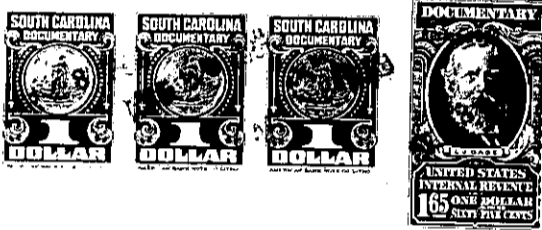
That W. E. Shaw, in the State aforesaid, in consideration of the sum of One Dollar and other considerations-----DOLLARS,

All that certain piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, being known and designated as lot #20, on the eastern side of Azalea Court, of a subdivision known as North Gardens, Section 2, according to plat made by Dalton & Neves, dated January 1955, and recorded in the R. M. C. Office for Greenville County in Plat Book EE, at page 103, and according to said plat, having the following metes and bounds:
