in consideration of the sum of Twenty-Three Thousand Five Hundred and No/100----- DOLLARS,

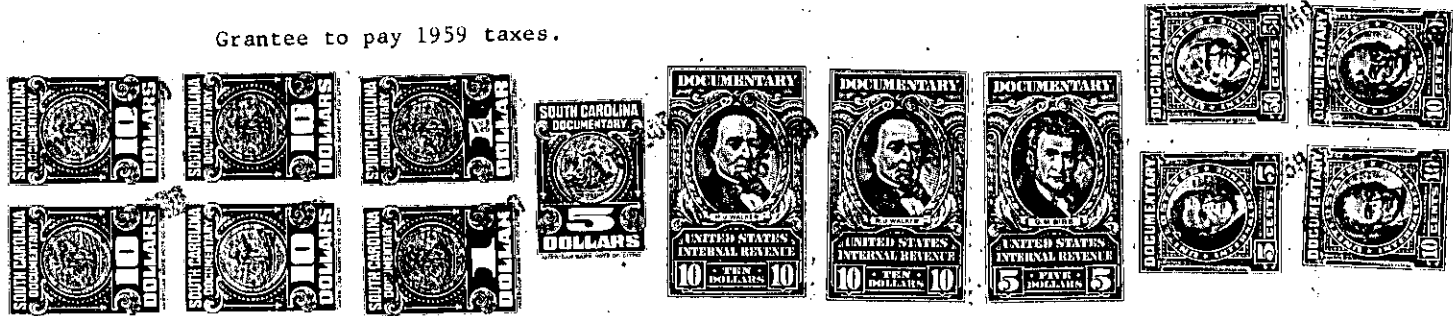

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 8, Section B, Plat of Elletson Acres, plat of which is recorded in Plat Book QQ, page 5, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Lowndes Avenue, joint front corner Lots 8 and 9; and running thence N. 30-43 W. 151.8 feet to an iron pin; thence S. 48-W. 86.7 feet to an iron pin; thence S. 30-43 E. 135.2 feet to an iron pin on Lowndes Avenue, joint front corner Lots 7 and 8; thence along Lowndes Avenue N. 59-17 E. 85 feet to an iron pin, the point of beginning.
