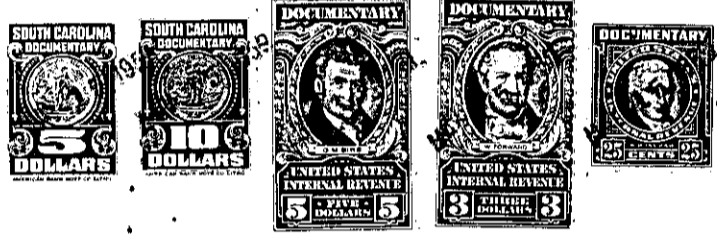
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mrs. Kate A. Johnston, her heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, and known and designated as lot #11 on the western side of Sycamore Drive, property of Leslie & Shaw, Inc., as shown on plat made by J. Mac Richardson, January 1959, and recorded in the R. M. C. Office for Greenville County in Plat Book MM, at page 103, and according to said plat having the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of lots #11 and #12, and running thence along the line of these lots, N. 69-17 W. 178.8 feet to an iron pin; running thence N. 21-47 E. 56 feet to an iron pin at the joint rear corner of lots #11 and #10; running thence along the joint line of said lots, S. 69-17 E. 177.8 feet to an iron pin on the western side of Sycamore Drive; thence along the western side of Sycamore Drive, S. 20-43 W. 56 feet to an iron pin, point of beginning.
