ALL that lot of land situate on the South side of Willow Spring Drive, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot 16 on plat of Section 7, of East Highlands Estates, made by Dalton & Neves, Engineers, April 1959, recorded in the RMC Office for Greenville County, S.C. in Plat Book MM, at page 99, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Willow Spring Drive, at joint front corner of Lots 15 and 16 and runs thence with the line of Lot 15, S. 35-03 W., 150 feet to an iron pin; thence N. 51-44 W., 83.1 feet to an iron pin; thence with the line of Lots 1, 2 and 3, Section 2, N. 31-06 E., 150 feet to an iron pin on the South side of Willow Spring Drive; thence along Willow Spring Drive, S. 52-15 E., 93.4 feet to the beginning corner.

This property is conveyed subject to the following building restrictions:

1. The lot herein conveyed shall be used for residential purposes only.
2. No residence shall be constructed on said lot having less than 900 square feet on the ground floor area exclusive of open porches and garages.
3. The building line as shown on the recorded plat is to be strictly adhered to.
