## **CHARTER** BY THE SECRETARY OF STATE

EXECUTIVE DEPARTMENT

WHEREAS,

JOHN S. TAYLOR, JR., and R. READ TULL

, 19 59 , file with the Secretary of State a written Declaration,

·signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is BOTANY WOODS, INCORPORATED

THIRD: That the principal place of business is 805 E. Washington, St., GREENVILLE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to buy, acquire, manage, develop, subdivide, improve, hold, sell and deal in real estate, and build and construct improvements, with all powers usually exercised by such corporations, together with all powers now or hereafter conferred upon similar corporations by law.

Twenty-five Thousand (\$25,000.00)---- Dollars FIFTH: That the amount of the capital stock is payable in cash and property.

SINTH: That the number of shares into which the capital stock is divided is - Two Hundred Fifty (250)
