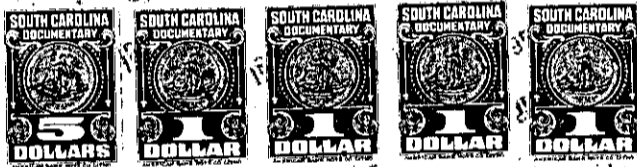

B. E. Huff and Gladys R. Huff, their heirs and assigns forever:

All of that lot of land in the County of Greenville, State of South Carolina, known as lot 2 on plat of property of G. W. Hawkins made by C. O. Riddle dated April, 1956 and recorded in the R.M.C. Office for Greenville County in plat book LL at page 5 and having, according thereto, the following metes and bounds, to-wit:

Beginning at an iron pin in the center of Berea Drive which iron pin is located 911.3 feet northeast of the White Horse Road and running thence along the line of lot no. 3, N 14-38 W, 507.7 feet to an iron pin; thence along the B. E. Huff property, N 71-06 E, 520.2 feet to an iron pin; thence along Purvis Hendricks S 16-22 E, 91.7 feet to an iron pin in the center of Berea Drive; thence following the center of said drive, the following courses and distances, to-wit: S 78-50 W, 100 feet to an iron pin; thence S 49-21 W, 100 feet to an iron pin; S 25 W, 175.3 feet to an iron pin; S 13-34 W, 164 feet to an iron pin; S 22-42 W, 100 feet to an iron pin; S 39-24 W, 100 feet to the point of beginning, said tract containing 2.93 acres, more or less and being the same conveyed the grantor by deed of G.
