

· LOTS 1 and 2: BEGINNING at an iron pin on the south side of the right of way of U. S. Highway No. 291, in the center of Tulip Street; thence with the center of said street S. 36-30 W. 112.3 feet to an iron pin corner of Lot No. 3, shown on the John Russell plat; thence with the line of said lot S. 53-10 E. 186.1 feet to an iron pin; thence N. 0-30 W. 195 feet to an iron pin on the south side of the right of way of South Carolina Highway No. 291; thence with the south side of said right of way N. 85-12 W. 79.8 feet to the beginning corner.

LOT 4: BEGINNING AT AN IRON PIN on the Southeastern side of Tulip Street at the joint front corner of Lots Nos. 3 & 4 and running thence with the joint line of said lots S. 54-10 E. 177.2 feet to an iron pin; thence S. 1-45 E. 27.5 feet to an iron pin in the Northern side of the right of way of the P. & N. Railroad; thence with said right of way N. 72-20 W. 224 feet to an iron pin on the Southeastern side of Tulip Street; thence with said Tulip Street, N. 36-30 E. 127.3 feet to the beginning corner. It is the intention of the grantor to convey to the Grantee all his right, title and interest in said lot to the right of way of the P. & N.
