Know All Men by These Presents:

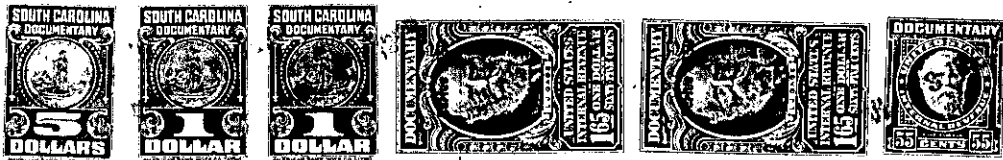

Joseph C. Edwards, his heirs and assigns forever:

All of that lot of land in the County of Greenville, State of South Carolina, shown as lot 16, Block C on plat of Hughes Heights recorded in the R.M.C. Office in plat book GG at page 122 and having the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of West Parker Road at the corner of lot no. 15 and running thence S 26-26 W, 177.4 feet to an iron pin on a service drive; thence N 56-30 W, 77.6 feet to an iron pin; thence N 26-26 E, 167.7 feet to an iron pin on West Parker Road; thence with said road S 66-34 E, 77 feet to the point of beginning and being the same property conveyed to us in deed book 606 at page 475.
