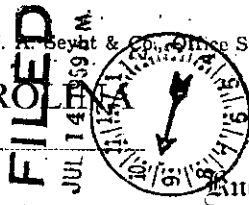

Moore and Louise Moore, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 77, on a Plat of Wynette Estates by Pickell & Pickell Engineers, dated July 24, 1953, recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 37, and having according to said plat the following metes and bounds, to-wit:
