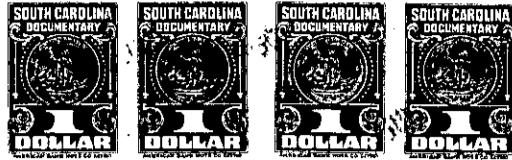

Know All Men by These Presents:

That W. James Williams, as trustee in the State aforesaid, in consideration of the sum of Nineteen Hundred Ninety and no/100-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Barnett Osborne Hiott, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, State of South Carolina, and known and designated as Lots #8 and #9, part of Avon Park, according to plat by C. C. Jones, dated December 1956, plat of which is recorded in the R. M. C. Office for Greenville County, in Plat Book KK, at page 71, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of lds #7 and #8, and running thence along the line of these lots. N. 15-53 E. 162.5 feet to an iron pin; thence S. 66-15 E. 91 feet to an iron pin at the joint rear of lots #8 and #9; running thence N. 55-38 E. 41.7 feet to an iron pin on the western side of Strange Road; running thence along the western side of Strange Road, S. 30-27 E. 90 feet to an iron pin; thence continuing along the western side of Strange Road, S. 37-37 E. 115.7 feet to an iron pin at an intersection, which intersection is curved the chord of which is S. 25-50 W. 38.8 feet to an iron pin on the northern side of Sheffield Lane; thence along the northern side of Sheffield Lane N. 78-17 W. 150 feet to an iron pin; thence N. 74-07 W. 30.2 feet to an iron pin, thence continuing along the northern side of Sheffield Lane N. 74-07 W. 88 feet to an iron pin, point of beginning.

This being a portion of the property conveyed to the Grantor by Matilda Phillips, et al, Mary B. Bierman, James Barnes and Marshall Barnes, by deeds recorded in the Greenville County R. M. C. Office in Vol. 553, at pages 249, 252, 255 and 261.
