FEW AND SINA N. FEW, Their Heirs and Assigns:

All that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina lying on the south side of the Old State Road and lying on the north side of a road known as W. S. Dill road and bounded on the west by lands of J. Carlton and land of Hollifield and on the east by land of Clora G. Howard and containing Four and 77/100 Acres, more or less, with Metes and Bounds as follows:

Beginning at an iron pin, a corner on J. Carlton's line and corner between Clora G. Howard and Terry T. Dill lands and on the north side of road, and running thence N. 66-30 E. 842 feet to iron pin on Hollifield's land, thence S. 41-30 E. 72 feet to iron pin; thence N. 66-30 E. 510 feet to corner on south side of the Old State Road; thence S. 46-15 E. 186 feet to iron pin; thence S. 43-45 W. 230 feet to iron pin; thence N. 46-15 W. to stake; thence S. 72-22 W. 645 feet to stake by a double White Oak; thence S. 44-05 W. 254 feet to point in center of road; thence with road as line N. 76-30 W. 394.2 feet to beginning.
