Know All Men by These Presents:

That We, W. W. Wilkins and G. Dewey Oxner, in the State aforesaid, in consideration of the sum of --Thirteen Hundred Seventy-five and 00/100 (\$1375.00) -DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Dennis L. Medlock, his heirs and assigns:

All that piece, parcel or lot of land in the City of Greenville, State of South Carolina, known and designated as Lot Two (2) on plat of Carver Court made by Piedmont Engineering Service, March, 1955, and recorded in the R.M.C. Office for Greenville County In Plat Book I I, page 107, and having according to said plat the following courses and distances, to wit:

BEGINNING at an iron pin on Elder Street, joint front corner of Lots 2 and 3; thence along the line of Lot No. 3 N. 63-30 W. 142.9 feet to a planting strip; thence along said planting strip S. 52-58 W. 161.4 feet, more or less, to a creek; thence along said creek in a southeasterly direction 172.6 feet, more or less, to rear corner of Lot No. 1; thence along the line of Lot No. 1 N. 59-21 E. 132 feet, more or less to an iron pin on Elder Street, joint corner of Lots 1 and 2; thence along curve of Elder Street, the chord of which is N. 14-48 W. 51 feet to the beginning corner.

The lot above described is conveyed subject to the covenants and restrictions recorded in the R.M.C. Office for Greenville County in Deed Book 526, page 297, which are made a part hereof as fully as if set out herein, and to the public utility easement granted to the Duke Power Company, dated September 1, 1955, and recorded in the R.M.C. Office for Greenville County in Deed Book 536, page 484, and also to the drainage and sewer easements shown on the plat of said property heretofore mentioned.

The lot herein conveyed constitutes a portion of the property conveyed to us by Jessie D. Webster by deed dated September 28, 1954, and recorded in the R.M.C. Office for Greenville County in Deed Book 509, page 122.
