Know All Men by These Presents:

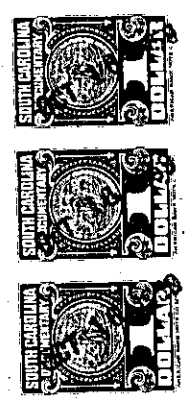

All that piece, parcel or lot of land situate, lying and being on the Southeastern side of Cammer Avenue in the City of Greenville, State of South Carolina and known and designated as Lot No. 38 on a plat of property of G. F. Cammer, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "L" at Page 115 and according to said plat having the following metes and bounds to-wit:

BEGINNING at an iron pin on the Southeastern side of Cammer Avenue at a point 73.6 feet northeast of the Eastern corner of the intersection of Cammer Avenue and Meyers Drive and also the joint front corner of Lot Nos. 37 and 38 and running thence along the Southeastern side of Cammer Avenue N 40-47 E 74 feet to an iron pin at the joint corner of Lots Nos. 38 and 39 and running thence S 40-10 E 202.2 feet to an iron pin, running thence S 40-50 W 60 feet, running thence N 44-06 W 200.6 feet to an iron pin, point of beginning.
