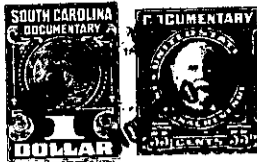

Know All Men by These Presents:

That We, James B. Pressly and Samuel H. Fisher

in the State aforesaid,

in consideration of the sum of Two Hundred Eighty-nine and 94/100 (\$289.94)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Alfred L. Smith and Christine Ashmore Smith, their heirs and assigns forever

All that piece, parcel or tract of land containing 1.09 acres, more or less, situate, lying and being in Bulter Township, Greenville County, State of South Carolina, and having according to a plat prepared by J. C. Hill, dated November 4, 1959, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of an unnamed County road at the joint corner of the property of the Grantors and the Grantees herein and running thence with the joint line of said property N. 56-27 W. 1263.9 feet to an iron pin; thence N. 40 E. 78.9 feet to an iron pin on the south side of the unnamed County Road and running thence with the south side of said road the following courses and distances: S. 36-20 E. 125 feet to an iron pin; thence S. 44 E. 100 feet to an iron pin, thence S. 57-40 E. 382 feet to an iron pin; thence S. 56-0E. 558 feet to an iron pin; thence S. 51-35 E. 51 feet to an iron pin; thence S. 26 E. 27 feet to an iron pin; thence S. 5 E. 36 feet to the beginning corner.

This being a portion of the property conveyed to the Grantors herein by A. E. and Etta Pitts by their deed dated September 19, 1958 and recorded in the R. M. C. Office in Deed Book 606 at page 14.

The grantors agree to pay taxes for the year 1959 on said property.

Reference is made to the above mentioned plat recorded in Plat Book TT page 89

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
