W. Fore, his heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being known and designated as lot 431, Section D, Shasta Drive, in a subdivision known as Englewood Estates, as shown by a plat thereof, dated February 1955, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "BB", at page 177, and having the following metes and bounds:

BEGINNING at an iron pin on the southwest side of Shasta Drive at joint corners of lots 432 and 431 and running S. 36-20 E. 75 feet to an iron pin on Shasta Drive at joint front corners of lots 431 and 430; thence with the common line of lots 431 and 430 S. 53-40 W. 157.5 feet to an iron pin at corners of lots 431, 430, and 435; thence with the line of lots 431 and 435 N. 84-55 W. 28 feet to an iron pin in the line of lot 435, at joint rear corners of lots 434 and 431; thence with the common line of lots 434 and 431 N. 5-08 E. 73.4 feet to an iron pin at joint rear corners of lots 434, 433 and 431; thence with the line of lots 431 and the rear lines of lots 433 and 432 N. 53-40 E. 130 feet to an iron pin on Shasta Drive, the point of beginning.

Restrictions: The above described property is not to be sold, rented or otherwise disposed of to any Negro or person of African descent. No residence shall cost less than \$8,500.00; no residence shall be erected nearer than 50 feet to the front line; and no residence shall be erected unless said lot has 50 feet, or more, frontage. No outside toilets are permitted; sewage must be disposed of by approved septic tanks.

This property is conveyed subject to any rights of way now in existence.

GRANTEE herein to pay taxes for the year 1960.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
