made.

warrant and forever defend the said premises to the said H.V. & Ann Ernest, their - - - - -
heirs and assigns against itself and its successors, and against every person whomsoever lawfully claiming or to
claim the same or any part thereof; subject, however, to the restrictions and limitations herein contained.
