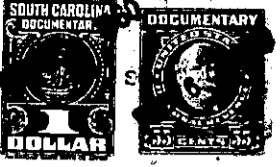

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lewis J. Tucker, his heirs and assigns, forever:

all that certain piece, parcel or lot of land, situate, lying and being in the County and State aforesaid, on the East bank of the South Saluda river, adjoined by land of Dorothy Farrell on the South and Sherwood Road on the East and North, known as Lot no. 4, and having the following metes and bounds, to-wit:

BEGINNING at a point on the W/S of Sherwood Road, joint corner of this lot and that of Farrell and running S 05 W 130 feet to a point in center of said river; thence following center of said river in a Northern direction 111 feet to a point; thence following said road on the W/S in a Southerly direction 197 feet to the beginning corner.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
