BEGINNING At an iron pin on the eastern side of Broad Vista Boulevard at the joint front corner of Lots Nos. 116 and 117 and running thence along said Boulevard N. 13-20 W. 80 feet to an iron pin at joint front corner of Lots Nos. 117 and 118, which iron pin is 145.4 feet south of Dove Lane and running thence along the joint line of Lots 117, 118 and 119, N. 69-10 E. 230.9 feet to an iron pin in the center of a five-foot utility easement; thence S. 2-0 W. 135 feet to an iron pin, joint rear corner of Lots Nos. 116 and 117; thence along the joint line of said lots, S. 83-0 W. 194.8 feet to the point of beginning.
