This contract made and entered into by and between J. E. Strickland

hereinafter referred to as the Seller(s) and T. J. Camp

hereinafter referred to as the Purchaser(s).

WITNESSETH

That in and for the consideration hereinafter expressed, the Seller agrees hereby to sell and convey to the Purchaser and the Purchaser hereby agrees to purchase that parcel of land situate in the County of Greenville, State of South Carolina, containing 1 acre located in Gantt Township fronting on Lynch Dr. with commencement point being 150 feet from the intersection of Lynch Dr. and White Horse Rd. and other dimensions of said lot being 210 feet square with a 7 room frame house situate thereon

IN CONSIDERATION for said premises, the purchaser agrees to pay to the Seller a total of Six Thousand Five Hundred Dollars for said lot(s) as follows: \$400.00 in cash, receipt thereof being hereby acknowledged by seller and the balance at \$50.00 per month commencing January 10, 1960 and each month thereafter until paid in full with interest at the rate of 6 per cent to be computed and paid monthly by first deduction from above payment and balance of said payment to principal.

IT IS UNDERSTOOD AND AGREED, that the Purchaser will pay all taxes upon said lot(s) from and after the date of this contract and will insure all building improvements against loss for the price herein.

In the event any monthly installment is in arrears and unpaid for a period of 15 days, this contract shall, at the option of the Seller, thereupon terminate and any and all payments made by the purchaser prior thereto shall be forfeited by the Purchaser to the Seller as rent for the use of said premises and as liquidated damages for the breach of this contract.

**Taxes and insurance to be pro rated for the year 1959.**

Upon the payment of the purchase price above set forth, the Seller does hereby agree to execute and deliver to said Purchaser a good, fee simple general warranty deed to said property with dower renounced thereon.
