OLLIE ... KNOWN ALL MEN BY THESE PRESENTS:

That I B.P. Bridwell in the State aforesaid, in consideration of the sum of One Hundred & No/100 (\$ 100.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Franklin E. Bridwell his heirs and assigns forever.

All that certain lot of land approximately 3 miles from Greenville, being a portion of a 10 acre tract of land conveyed to J.A. Quinn by E. Innman, Master, by deed recorded in Volume 169 at page 137, containing .69 of an acre, according to survey and plat made J.C. Hill, February 27, 1951, and having the following metes and bounds, to-wit;

BEGINNING at an iron pin near road, at corner of tract conveyed to J.A. Quinn Jr, and running thence with line of said tract, S-57-55-W 299.1 feet to an iron pin; thence N-32-05 W 98.6 feet to iron pin at corner of Quinn Estate; thence with the line of Quinn estate N-57-55-E 305.2 feet to iron pin near road; thence S-28-39-E 99.3 feet to the beginning corner.

Said premises being the tract first described in the deed recorded in Volume 430 at page 261.

Grantee is to pay the 1960 taxes.

This being the same lot of land conveyed to Grantor by T.C. Quinn dated August 11th 1951 by deed, said deed of record in the R.M.C. Office in Book 439 at page 541.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and His Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
