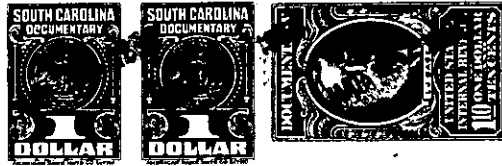

That I, Harry O. Hill, in consideration of the sum of --NINE HUNDRED AND NO/100 (\$900.00)----- DOLLARS,

to the grantor in hand paid at and before the sealing of these presents by the grantee (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William B. Ellis, III, his heirs and assigns,

All that piece, parcel, or lot of land in the City of Greenville, County of Greenville, State of South Carolina, lying and being situate on the South side of Pacific Avenue, being known and designated as Lot 357, according to plat of Pleasant Valley subdivision, prepared by Dalton and Neves, Engineers in April, 1946 as revised through July, 1954 and as recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book BB at page 163, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Pacific Avenue at joint front corner of Lots 356 and 357 and thence along the joint lines of those lots S.0-08 E. 255.8 feet to an iron pin at the joint rear corner of lots 356 and 357; thence N.62-34 E. 67.65 feet to an iron pin at joint rear corner of lots 357 and 358; thence along the joint line of those lots N.0-08 W. 224.8 feet to an iron pin at joint front corner of lots 357 and 358 on the South side of Pacific Avenue; thence along said Pacific Avenue, S.89-52 W. 60 feet to an iron pin at joint front corner of lots 356 and 357, the point of beginning.

The hereinnamed grantee is to pay the 1960 taxes on the above described property.

The abovedescribed property is subject to restrictions recorded in the R.M.C. Office for Greenville County, S. C. in Deed Volume 301, page 60.
