

Voyles, said plat being recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "Y" at page 73, and having, according to said plat the following metes and bounds, to wit:

Beginning at a stake on the northerly side of Echols Drive, said stake being 386.8 feet east of the intersection of Echols Drive and Augusta Road, at joint front corner of Lots 3 and 4; thence with the line of lot, 3 N. 21-42 W. 115 feet to an iron pin; thence N. 68-18 E. 100 feet to an iron pin, at joint rear corners of Lots 4 and 5; thence with the line of lot 5, S. 21-42 E. 115 feet to an iron pin on Echols Drive; thence with Echols Drive, S. 68-18 W. 100 feet to the beginning corner.
