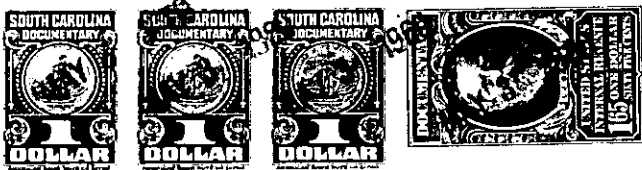
OLLIE ... Know All Men by These Presents:

Frank Williams, in the State aforesaid, in consideration of the sum of Eleven Hundred and no/100 - - - (\$1100.00) - - - - - DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. D. Shedd, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 17 of Western Hills, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book QQ at pages 98-9, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Watkins Road, at joint front corner of Lots 17 and 18, and running thence with the line of said lots, S. 60-47 W., 175 feet; thence S. 5-44 E., 98.2 feet; thence N. 60-47 E., 214.3 feet to an iron pin on the eastern side of Watkins Road; thence with Watkins Road, N. 29-13 W., 90 feet to the point of beginning.

This conveyance is subject to the recorded restrictions applicable to Western Hills and to the easements as shown on said plat.
