

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in Butler Township, near the City of Greenville, being shown as Lot No. 6 on a plat of Lake Forest Heights, made by Piedmont Engineering Service, November, 1955, and recorded in Plat Book "GG" at Page 153, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Yancey Drive, joint front comer of Lots Nos. 6 and 7, and running thence along the line of Lot No. 7, S. 73-13 W. 266.6 feet to an iron pin, same being at the joint rear corner of said Lots Nos. 6 and 7; thence N. 13-18 W. 110.1 feet to the joint rear corner of Lots Nos. 5 and 6; thence along the line of Lot No. 5, N. 73-13 E. 260.9 feet to an iron pin at joint front comer of Lots Nos. 5 and 6; thence along the western side of Yancey Drive S. 16-47 E. 110 feet to the beginning comer.

This conveyance is made subject to the restrictive covenants applicable to the lots shown on the plat above referred to, which are expressly made a part of this deed by reference, said restrictions being recorded in the R.M.C. Office for Greenville County – same office in which the plat aforesaid is recorded – in Deed Book 539 at page 123.
