Tidwell in consideration of the sum of Twenty-Three Hundred and Fifty and No/100 (\$2350.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Dwight W. Hughey, his heirs and assigns forever:

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as Lot No. 9, ON Mills Avenue according to a News Survey of Kirkwood Heights Sub-division made by Pickell and Pickell, Engineers, June 28, 1960. Said plat being designated as a portion of Kirkwood Heights Sub-division, said plat being recorded in the RMC Office for Greenville County at Plat Book RR, Page 45, beginning and having the following metes and bounds to wit:
