KNOW ALL MEN BY THESE PRESENTS That WILKINS NORWOOD & COMPANY, INC. a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the sum of One Thousand Eight Hundred Fifty and No/100ths (\$1,850.00)-----dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto DONALD E. BALTZ:

All that parcel or lot of land lying and being in the County of Greenville, State of South Carolina, being designated as Lot No. 21 as shown on Plat No. Three, Cherokee Forest, prepared by J. Mac Richardson, R.L.S., in January, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book QQ at pages 36 and 37, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Vicki Circle at the joint corner of Lot No. 20 as shown on said plat, and running thence along the line of Lot No. 20 N. 4-31 E. 200 feet to an iron pin; thence S. 85-29 E. 100 feet to an iron pin; thence S. 4-31 W. 200 feet along the line of Lot No. 22 to an iron pin on the Northern side of Vicki Circle; thence along the Northern side of Vicki Circle N. 85-29 W. 100 feet to an iron pin, the point of beginning.

The foregoing lot is a portion of that conveyed to Wilkins Norwood & Company, Inc. by deed of Lucile L. Smith, et al, dated September 15, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 634 at page 188.
