Shepard, her heirs and assigns, all my undivided one-half interest in that certain piece, parcel, or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, and in Paris Mountain Township and having, according to a plat made by C. O. Riddle, R. L. S., on July 9, 1959 which plat is recorded in Plat book UU at page 73, the following metes and bounds, to-wit:

BEGINNING at an iron pin in N. Parker Road (formerly New Poor House Road) and running thence N. 84-02 W. 1,052.7 feet to an iron pin in Parker Road; thence N. 10-10 W. 88 feet; thence N. 8-26 E. 134.5 feet; thence N. 21-26 E. 324.2 feet to an iron pin in Parker Road; thence S. 73-37 E. 980.9 feet to an iron pin in N. Parker Road; thence S. 2-45 W. 354.9 feet to the point of beginning, consisting of 10.62 acres.

The above described property is the same conveyed to Henry E. Stewart by deed of C. O. Hobbs dated January 22, 1920 and recorded in the R. M. C. office for Greenville County in Volume 68 at Page 26 and was devised to the grantee and the grantor's father according to the will of Henry E. Stewart in the Probate Court for Greenville County in Apt. 449, File 27. The grantor is the sole heir of his father, Harry E. Stewart Jr.
