ALL that lot of land with the buildings and improvements thereon, situate on the South side of Lee Road, near the City of Greenville, in Greenville County, S. C. shown as Lot No. 3 on plat of property of William B. Ducker, made by Dalton & Neves, Engineers, January 1960; recorded in the RMC Office for Greenville County, S.
