Kenneth R. Kressler and Helen L. Kressler, their heirs and assigns forever:

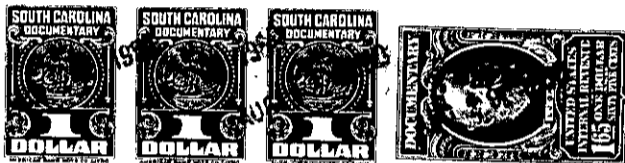
