ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 2 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Avery Street at the joint front corner of Lots 1 and 2 and running thence with the Southeastern side of Avery Street S 61-04 W 90 feet to a point at the joint front corner of Lots 2 and 3; thence S 28-56 E 148.5 feet to a point at the joint rear corner of Lots 2 and 3; thence N 58-22 E 90.1 feet to a point at the joint rear corner of Lots 1 and 2; thence N 28-56 W 144.2 feet to the point of beginning.
