

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, in the City of Greenville, situate on the southest side of Pinckney Street between Mulberry and Frank Streets, being known as Lot 6 on a plat made by W. D. Neves February 7, 1912, and being more particularly described as follows:

BEGINNING at a stake on Pinckney Street 128.4 feet inches from Pinckney Street Public School property and running thence along Pinckney Street S. 34 E. 64 feet 2 inches to corner of lot formerly owned by W. H. Irvine; thence with line of said lot S. 57-30 W. 199 feet to a stake; thence N. 33-15 W. 64 feet 5 inches along the line of Lot No. 1 to a stake at joint corners of Lots 1, 2, 5 and 6; thence N. 57-40 W. 198 feet to the point of beginning.
