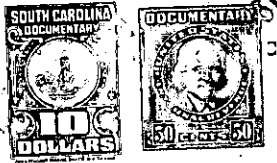

Mary Louise Pendleton, her heirs and assigns forever:

All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as Lot 2 on Plat of Knollwood of record in the R.M.C. Office for Greenville County in Plat Book EE, at Page 35 and being more particularly described according to said plat as follows:

BEGINNING at a point on the south side of Meyers Drive at the joint front corner of Lots 2 and 3; thence S. 18-42 W. 158.8 feet along line of Lot 3 to the rear corner thereof; thence N. 66-46 W. 137.9 feet to the rear corner of Lot 1; thence N. 40-46 E. 163.8 feet along line of Lot 1 to the front corner thereof on Meyers Drive; thence S. 48-30 E. 10 feet along Meyers Drive to point; thence S. 71-18 E. 66.6 feet along Meyers Drive to the front corner of Lot 3, point of beginning; being a part of the same property deeded to us by Julia M. Jenkinson, et al. by their deed dated September 6, 1948, and recorded in the R.M.C. Office for Greenville County in Deed Book 358, Page 213.
