Ray, her heirs and assigns forever;

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being near the City of Greenville, Greenville County, South Carolina, being known and designated as Lot No. Fourteen (14), Sylvan Hills, as per plat thereof recorded in the RMC Office of Greenville County, South Carolina, in Plat Book "S", at Page 103 and having, according thereto, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Collinson Road at the joint front corner of Lots No. Thirteen (13) and Fourteen (14), and running thence N. 05-36 W. 150 feet to an iron pin, being the joint rear corner of Lots Thirteen (13) and Fourteen (14); thence running S. 84-24 W. 70 feet to an iron pin, being the joint rear corner of Lots Fourteen (14) and Fifteen (15); thence running S. 05-36 E. 150 feet to an iron pin on the northern side of Collinson Road, being the joint front corner of Lots Fourteen (14) and Fifteen (15); thence running along the northern side of Collinson Road N. 84-24 E. 70 feet to an iron pin, the point of beginning.
