All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as lot #2, on the western side of Edwards Road, of a subdivision known as Dogwood Terrace, as shown on a plat prepared by J. BEGINNING, at an iron pin on the western side of Edwards Road, the joint front corner of lots #2 and #3, and running thence along the line of lot #3, S. 84-06 W. 180.2 feet to an iron pin in the line of lot #4; thence S. 0-51 E. 29 feet to an iron pin; thence S. 4-21 E. 52.1 feet to an iron pin at the joint rear corner of lots #2 and #1; thence N. 83-50 E. 184.8 feet to an iron pin on the western side of Edwards Road; thence along the western side of Edwards Road, which line is curved, the chord of which is N. 6-10 W. 80 feet to an iron pin, point of beginning.
