

All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 52 of a subdivision known as Chestnut Hills No. 1 as shown on plat thereof prepared by R. K. Campbell, Surveyor, August 28, 1959 and recorded in the R.M.C. Office for Greenville County in Plat Book QQ, at Page 83 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern edge of Kathryan Court, the joint front corner of Lots Nos. 51 and 52 and running thence along the joint line of said lots, N. 64-28 W. 128.8 feet to an iron pin at the joint rear corner of Lots Nos. 45 and 46; thence along the rear line of Lot No. 45, N. 43-0 E. 167.5 feet to an iron pin at the joint rear corner of Lots Nos. 45 and 44; thence along the joint line of Lots Nos. 52 and 53, S. 29-51 E. 130.5 feet to an iron pin on the northwestern edge of Kathryan Court; thence along the northwestern edge of Kathryan Court following the curvature thereof, the chord of which is S. 51-05 W. 45 feet to an iron pin; thence continuing along the northwestern edge of Kathryan Court, following the curvature thereof, the chord of which is S. 36-55 W. 45 feet to the beginning corner; being a portion of the property conveyed to the granting corporation by Chestnut Hills, Inc. by its deed dated April 9, 1959 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 621, at Page 383.

This conveyance is subject to restrictions and protective covenants recorded in the R.M.C. Office for Greenville County in Deed Vol. 634, at Page 295 and is also subject to recorded easements for the installation and maintenance of public
